**CHILD CARE FEES AND TUITION AND PAYMENT POLICIES**

- Credit is not given for days your child does not attend (which would include sick days or vacation), or for days the school does not open due to emergency closings, delayed openings or early closings. Days cannot be rescheduled.
- Changes to enrollment must be approved by the Director and received 15 days prior to the first of each month. Changes to your child's schedule are effective the first day of any month.
- Written notice is required if you need to withdraw your child from the Child Care program. Deposits are non-refundable and non-transferable. If 45 days written notice is provided, the deposit will be applied to the child's last month of enrollment.
- Your child also must be a member of the Fanwood-Scotch Plains YMCA to participate in Child Care. Canceling out of Child Care does not automatically cancel your membership. This must be done separately online or at our Welcome Center.
- **Deposits are non-refundable and non-transferable**

**RELEASE AND WAIVER OF LEGAL LIABILITY**

- I, individually and on behalf of my minor child(ren), hereby release and hold the Fanwood-Scotch Plains YMCA, its assigns and successors, its directors, officers, volunteers, and/or others acting on its behalf harmless from all claims that I/we may have arising from activities that I/we may be involved in with the YMCA. I expressly and specifically assume any and all risk of injury, illness, death, or property damage resulting from my/our YMCA activities. I hereby release the YMCA from any claim whatsoever which may arise as a result of any first aid, treatment, or services or assistance provided to me/us in connection with any injury that arises from activities at the YMCA. I take full responsibility for my/our welfare and safety at YMCA activities. I hereby give permission for emergency medical treatment to be administered as deemed appropriate. I understand that the YMCA does not carry insurance to cover injuries and losses that may befall me/us. I consent to be photographed and to allow YMCA's use of any photos of me or my minor child(ren) for publicity reasons. The Y is a membership facility. Members are required to scan in when entering our facility. The YMCA conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation, and remove visitation access.

- I understand that I must have an active membership while enrolled in the child care program. I understand that cancelling out of Child Care does not automatically cancel my membership.
